THE 18TH HONG KONG ARTS DEVELOPMENT AWARDS

The 18TH Hong Kong Arts Development Awards is now open for nominations.

Organised by the Hong Kong Arts Development Council (HKADC), the Hong Kong Arts Development Awards is an annual flagship event in the local arts scene. It aims to give formal recognition to distinguished arts practitioners, groups and organisations that have made significant contributions to the arts development in Hong Kong.

Besides paying tribute to veteran arts practitioners, the Awards scheme presents different awards to recognise arts practitioners and up-and-coming artists with outstanding achievements. It also commends individuals and organisations that have actively participated in arts education and promotion, as well as patrons who have generously supported local arts events. By conferring the awards, the scheme aims to introduce diverse arts talents to the community, and to encourage active community support to the arts development in Hong Kong.

藝術家年獎

表揚在各個藝術界別有傑出表現的藝術工作者，得獎單位可獲港幣50,000元進行創作、藝術活動或進修

藝術新秀獎

表揚、支持及鼓勵年青和新晉藝術工作者，得獎單位可獲港幣25,000元進行創作、藝術活動或進修

學校藝術教育獎

表揚在校園內致力推動藝術教育並有卓越成績的學校

藝術推廣及教育獎

表揚在藝術推廣及教育方面有卓越成績的計劃

藝術贊助獎

表揚積極贊助本地藝術活動及推動藝術發展的機構及人士

AWARD CATEGORIES

The 18TH Hong Kong Arts Development Awards is organised into seven categories.

For the following two awards, nominations and final selection are made by the HKADC's Council members and arts advisors:

LIFE ACHIEVEMENT AWARD^{Note 3}

The highest accolade in the Awards recognises the ongoing contributions of Hong Kong veteran arts practitioners whose achievements are widely acknowledged by the arts community.

AWARD FOR OUTSTANDING CONTRIBUTION IN ARTS^{Note 3}

Pays tribute to arts practitioners who have made outstanding contributions to various art forms during the past few decades.

The following five awards are open for nominations:

ARTIST OF THE YEAR

Recognises arts practitioners who have achieved excellence in their respective art forms; each awardee will receive a cash award of HK\$50,000 for supporting his / her / the artist collective's creative work, arts projects or further studies.

AWARD FOR YOUNG ARTIST

Gives recognition, support and encouragement to young and emerging arts practitioners; each awardee will receive a cash award of HK\$25,000 for supporting his / her / the artist collective's creative work, arts projects or further studies.

AWARD FOR ARTS EDUCATION IN SCHOOLS

Recognises schools that have outstanding accomplishments in arts education which take place on campus.

AWARD FOR ARTS PROMOTION AND EDUCATION

Recognises the outstanding projects in arts promotion and education.

AWARD FOR ARTS SPONSORSHIP

Recognises organisations and individuals that have actively sponsored arts events and promoted arts development in Hong Kong.

Note 3 The "Life Achievement Award" (previously known as the "Honorary Award") and the "Award for Outstanding Contribution in Arts" are not presented posthumously. Previous recipients of these two awards will not be nominated for the same award again.

評審機制及評選流程

設總評審團及評審小組負責獎項評選工作。

總評審團

由藝發局現屆正副主席（兩位）、上屆正副主席^{註4}（兩位）、現屆大會委員（三位）組成，負責：

- 檢視獎項的整體性及所有程序細節；
- 考慮各評審小組建議的得獎名單並作決定；及
- 決議為各獎項的最終結果。

評審小組

- 各獎項均設評審小組，由業界專業人士組成，包括界內不同藝術界別的代表；
- 負責評選五個公開接受提名之獎項及建議得獎名單，即「**藝術家年獎**」、「**藝術新秀獎**」、「**學校藝術教育獎**」、「**藝術推廣及教育獎**」及「**藝術贊助獎**」；
- 評選結果將交由總評審團檢視及考慮通過；
- 為確保評選工作公平及公開，及避免候選單位與評審小組成員構成任何利益衝突，本局將待確定各獎項的候選名單後，再邀請相關業界專業人士、並與候選單位沒有任何利益衝突者擔任評審小組成員；
- 獎項提名人亦不會獲安排參與所提名獎項組別的評審工作；
- 總評審團及評審小組成員名單將上載至藝發局網站，供公眾瀏覽。

評選流程

- 由藝發局大會及藝術顧問負責提名及推選「**終身成就獎**」及「**傑出藝術貢獻獎**」。
- 由評審小組負責評選五個公開接受提名之獎項，當中「**藝術家年獎**」及「**藝術新秀獎**」由所屬藝術界別的評審小組評選。
- 所有建議得獎名單交由總評審團檢視及考慮通過。
- 所有獎項的評選過程均保密進行，藝發局保留不頒發獎項的權利。

註4 如上屆及現屆正副主席為同一人，則邀請再前一屆正副主席擔任總評審團成員。

ADJUDICATION & ASSESSMENT PROCESS

A chief adjudication panel and assessment panels will be formed to adjudicate various awards.

CHIEF ADJUDICATION PANEL

The panel comprises Council Chairman and Vice Chairman of the current term (two persons), Chairman and Vice Chairman of the last term^{Note 4} (two persons) and Council members of the current term (three persons). They will be responsible for:

- Examining the holistic entity and all procedural details pertaining to the awards;
- Deliberating on the recommended awardee lists submitted by the assessment panels and making decisions; and
- Making resolution for the final result.

ASSESSMENT PANELS

- An assessment panel will be formed for each award. The assessment panels will comprise of arts professionals, including representatives from various art forms;
- They will be responsible for assessing nominations received for the following five awards: “**Artist of the Year**”, “**Award for Young Artist**”, “**Award for Arts Education in Schools**”, “**Award for Arts Promotion and Education**” and “**Award for Arts Sponsorship**”;
- The recommended awardee lists will be submitted to the chief adjudication panel for consideration;
- To ensure the assessment is conducted in an open and fair manner and avoid any conflicts of interest on the part of nominees and assessment panel members, the assessment panels will be formed only after all the nominations have been received and confirmed. They will consist of experts and representatives in the particular art form they assess;
- Nominators cannot participate in the assessment for the category in which they have made nominations;
- The list of chief adjudication panel and assessment panel members will be uploaded to the HKADC's website for public information at a later stage.

ASSESSMENT PROCESS

- The HKADC's Council members and arts advisors will nominate and elect recipients of the “**Life Achievement Award**” and “**Award for Outstanding Contribution in Arts**”.
- Various assessment panels will assess the candidates of the five awards that are open for nominations. “**Artist of the Year**” and “**Award for Young Artist**” will be assessed by the relevant art form panel.
- The recommended awardee lists will be submitted to the chief adjudication panel for consideration.
- The entire assessment process will be conducted in strict confidentiality and HKADC reserves the right to withhold the granting of any award.

Note 4 Where the same persons serve as the Council Chairman and Vice Chairman in the current and last term, the Chairman and Vice Chairman of the term before last shall be invited to sit in the chief adjudication panel.

提名須知

- 獎項的對象為本地藝術工作者、藝團，以及積極支持本地藝術活動的團體 / 機構及人士。
- 「藝術家年獎」、「藝術新秀獎」、「學校藝術教育獎」、「藝術推廣及教育獎」及「藝術贊助獎」均以公開提名方式報名。
- **任何人士 / 團體 / 機構須獲最少一個提名**，提名可以由個人或團體名義提出，但不能為候選單位本身。
- 每份提名表格的提名數目不限。
- 提名人 / 機構遞交提名表格前，須先徵得獲提名的候選單位同意。
- 所有得獎者 / 單位均不可轉名；提名表格上的候選單位（個人 / 團體 / 機構）的名字為最終得獎者 / 單位。
- 提名人 / 機構及候選單位須遵從藝發局評選結果的最終決定。

遞交提名及截止日期

- 各獎項均有獨立的提名指南及提名表格，詳列候選資格、評選準則等（詳見第16-25頁），提名人 / 機構及候選單位**必須**細閱有關資料，並交回填妥的表格及提供相關資料。
- 提名表格可經以下方式索取：

- 本局接受有效提名表格的複印本，但不接受自行仿製的表格。
- 提名截止日期為 **2023年10月27日（星期五）下午6時正**。
- 所有提名表格及有關資料必須於截止日期或以前經以下方式遞交：
 - 登入網上提名系統以電子方式填寫及遞交；
 - 親臨本局辦事處及投入收集箱內；
 - 以郵寄方式遞交（日期以郵戳為準）。
- 凡於截止日期後遞交或以傳真 / 電郵方式遞交的表格將不獲受理，本局亦不會接受任何在截止日期後提交的補充資料。
- 若以親身或郵寄方式遞交，提名表格及所有附件須以獨立包封遞交藝發局，並於信封面註明獎項類別，例如「藝術家年獎」。
- 提名表格上的資料及所有提交的參考資料均會保密處理。

NOMINATION GUIDELINES

- The Awards scheme's target participants include local arts practitioners and arts groups; as well as individuals and groups / organisations that actively support the arts development in Hong Kong.
- "Artist of the Year", "Award for Young Artist", "Award for Arts Education in Schools", "Award for Arts Promotion and Education" and "Award for Arts Sponsorship" are open for nominations.
- **Each individual / group / organisation must be nominated by at least one nominator (in his / her personal capacity or on behalf of an organisation)** in order to compete for an award. Self-nomination will not be accepted.
- There is no upper limit on the number of nominators.
- Nominators must obtain prior consent from the nominees before submitting nominations.
- Names of the nominees (individual / group / organisation) on the nomination form will be the final recipients of the awards; names of the award recipients cannot be changed.
- Nominators and nominees must abide by the HKADC's final decision.

ENROLMENT AND DEADLINE

- Each award has its own guidelines and nomination forms, which specify its eligibility and assessment criteria (see P.16-25). Nominators and nominees **MUST** read all the relevant information carefully and complete the appropriate forms.
- Nomination forms are now available at:
 - the Hong Kong Arts Development Awards Online Nomination System (Online Nomination System) **www.hkadawardsnomination.hk**;
 - the HKADC Administration Office (10/F, 1063 King's Road, Quarry Bay, Hong Kong; will be relocated to 5/F, Landmark South, 39 Yip Kan Street, Wong Chuk Hang, Hong Kong starting from 15 September 2023 (Friday));
 - the HKADC's Website **www.hkadc.org.hk/awards**.
- HKADC accepts photocopies of valid nomination forms, but will not accept replicas.
- The deadline for submission is **6pm on 27 October 2023 (Friday)**.
- Completed nomination forms and supporting documents must be submitted by the specified deadline via one of the following means:
 - by using the Online Nomination System **www.hkadawardsnomination.hk**;
 - by depositing into the collection box located at the HKADC Administration Office;
 - by post (will be accepted only if they are postmarked no later than the deadline).
- Late submissions and submissions sent by fax / email will not be accepted. HKADC will not consider supplementary information submitted after the deadline.
- Nomination forms and all attachments submitted in person or by post must be submitted to HKADC in a sealed envelope marked with the name of the relevant award. For example: "Artist of the Year".
- Information provided on forms and supporting documents will be kept confidential.

網上提名注意事項

- 登入「香港藝術發展獎網上提名系統」（網上提名系統）www.hkadawardsnomination.hk，以電子方式填寫及遞交提名。
- **系統只供候選單位註冊帳戶，提名人 / 機構無需註冊帳戶。**詳情請瀏覽用戶指南。
- 透過網上提名系統遞交提名的截止日期及時間同樣為 **2023 年 10 月 27 日（星期五）下午 6 時正**。凡於截止日期後遞交的提名將不獲受理，本局亦不會接受任何在截止日期後提交的補充資料。

公布結果及頒發獎項

- 藝發局將於2024年4月至5月以專函通知各得獎者 / 單位及其提名人 / 機構，並擬於2024年5月或6月舉行頒獎禮，邀請藝術界及社會知名人士參加，得獎者 / 單位將於典禮現場接受獎項。
- 各得獎者 / 單位將獲頒發獎座，其中「藝術家年獎」及「藝術新秀獎」的得主分別可獲港幣50,000元及25,000元獎金，進行創作、藝術活動或進修。
- 未有獲獎的人士 / 團體亦會於2024年4月至5月收到通知。

防止利益衝突

- 總評審團成員、藝發局大會委員及辦事處職員均不能接受獎項提名及參與競逐獎項，是次計劃的合辦及協辦機構亦不能接受提名。
- 由總評審團成員、藝發局大會委員及辦事處職員擔任最高負責人（例如行政總監、藝術總監、董事會主席等職位）的機構或團體，均不能接受獎項提名及參與競逐獎項。
- 為避免候選單位與評審小組成員構成任何利益衝突，本局將待確定各獎項的候選名單後，再邀請相關業界專業人士、並與候選單位沒有任何利益衝突者擔任評審小組成員。
- 獎項提名人亦不會獲安排參與所提名獎項組別的評審工作。
- 所有參與處理及評審的人士，須在開始評審工作前申報利益，並根據相關指引決定是否適合繼續處理評審工作。
- 各獎項的評審小組名單將上載至藝發局網站，供公眾瀏覽。

IMPORTANT NOTE FOR ONLINE NOMINATION

- By e-submission via the Hong Kong Arts Development Awards Online Nomination System (Online Nomination System) www.hkadawardsnomination.hk.
- **Registration of user account is applicable to NOMINEES only, nominators are not required.** For more informations, please refer to the user guide.
- The deadline and time for submitting nominations via the Online Nomination System is also **6pm on 27 October 2023 (Friday)**. Late submissions will not be accepted. HKADC will not consider supplementary information submitted after the deadline.
- The user guide of the Online Nomination System can be found on our website www.hkadc.org.hk/awards.

ANNOUNCEMENT OF RESULTS AND AWARD PRESENTATION

- Award winners and their nominators will be notified of the results by post in April and May 2024. HKADC will hold the awards presentation ceremony in May or June 2024. Noteworthy guests from the arts community and society will be invited to attend this function. The winners will receive their awards in person during the ceremony.
- All award winners will receive trophies in their respective categories, while recipients of “Artist of the Year” and the “Award for Young Artist” will each receive an additional cash award of HK\$50,000 and HK\$25,000 respectively for supporting their creative work, arts projects or further studies.
- Unsuccessful nominees will also receive notification in April and May 2024.

CONFLICTS OF INTEREST

- Members of the chief adjudication panel, Council members and employees of the HKADC cannot accept nomination or compete for the awards. Co-presenters and collaborating organisations of the Awards scheme are also ineligible to accept nomination.
- Organisations or groups where members of the chief adjudication panel, Council members and employees of the HKADC serve as the highest responsible persons (for example, Executive Director, Artistic Director, Chairman of the Board of Directors) cannot accept nomination or compete for the awards.
- To avoid any conflicts of interest on the part of nominees and assessment panel members, the assessment panels will be formed after all the nominations have been received and confirmed. They will consist of experts and representatives in the particular art form they assess.
- Nominators cannot participate in the assessment process for the category in which they have made nominations.
- All persons involved in the processing and assessment of nominations are required to declare interests, and determine whether it is suitable for him / her to continue processing the assessment according to the relevant guidelines prior to commencement of assessment.
- The list of assessment panel members will be uploaded to the HKADC's website for public information at a later stage.

提名人 / 機構及候選單位的責任

- 在任何情況下，提名人 / 機構及候選單位須確保藝發局不會因收取、審閱、持有、處理或儲存其提交送呈予藝發局的任何文件及資料、提名表格內容而違反香港《2000年知識產權（雜項修訂）條例》或其他相關條例；若藝發局因提名人/機構或候選單位未能遵守此規定而觸犯了任何相關的知識產權條例，提名人 / 機構或候選單位須完全補償藝發局因此而產生的任何損失。
- 提名人 / 機構及候選單位須同意藝發局有權在有需要時向提名人 / 機構、候選單位，或其他有關人士，索取提名表格上填寫之資料的口頭或書面證明。
- 為方便評審工作，提名人 / 機構及候選單位須同意藝發局有權把提名表格及其他所遞交的資料複印給其委員、總評審團及評審小組成員、文化體育及旅遊局、其他相關政府部門及外界顧問作參考之用。
- 提名人 / 機構或候選單位所遞交的文件及 / 或資料內容，如包括複製、派發或刊登其他人士 / 團體 / 機構擁有版權的作品、資料等（包括任何文件、語音、圖像 / 影像製作及其他形式等），提名人 / 機構或候選單位須負責事先取得有關版權擁有者的書面同意，使計劃能順利進行。
- 在提名表格內填報的個人資料及其他參考資料是供藝發局處理提名及安排評審工作。若提名人 / 機構或候選單位未能提供充足資料，可能會令評審工作無法進行。
- 所有候選單位均不可使用「本人 / 組合 / 學校 / 團體 / 機構曾被提名參與第XX屆香港藝術發展獎」等語句作宣傳或推廣之用。
- 藝發局保留基於以下理由取消候選單位之提名資格的權利：候選單位（或與其有關聯或參與候選計劃的人員或合作單位）曾經或正在作出（或藝發局有理由相信任何該等人士曾經或正在作出）任何可能構成或導致發生危害國家安全罪行或不利於國家安全的行為或活動；或藝發局認為有需要為維護國家安全、或保障公眾利益、公共道德、公共秩序或公共安全而取消該候選單位的資格。藝發局有權不理會或拒絕已被藝發局根據本段取消資格的候選單位之所有提名。
- 得獎單位須按本局的指引參加宣傳活動。
- 各獎項得獎者（及其成員、人員、合夥人、僱員、代理人、承包商、分包商、自由藝術家（如適用））在任何時間均須遵守在香港的所有法例、規則、規例及法例規定，並且不得作出任何可能構成或導致發生危害國家安全罪行或不利於國家安全的行為或活動。

RESPONSIBILITIES OF NOMINATORS AND NOMINEES

- Nominators and nominees must ensure that HKADC does not violate the Intellectual Property (Miscellaneous Amendments) Ordinance 2000 or other relevant ordinances as a result of the receipt, examination, possession, processing or archiving of documents submitted by them. If a nominator or nominee's failure to comply with this requirement causes HKADC to breach any copyright law, the individual or organisation concerned must compensate HKADC fully for any loss thus incurred.
- Nominators and nominees must agree that HKADC reserves the right to seek verbal or written proof from them or from other relevant parties regarding the information submitted on nomination forms.
- To facilitate the adjudication process, nominators and nominees must allow HKADC to reveal data contained in their submitted nomination forms to Council members, the chief adjudication panel, assessment panels, Culture, Sports and Tourism Bureau, other Government departments and external consultants.
- If the contents of documents submitted by nominators or nominees duplicate, distribute or publish works and other materials (in written, verbal, graphic, image, production or any other form) that the copyright of which belongs to other parties or organisations, it is the responsibility of the nominators or nominees to obtain the copyright owner's prior consent, to ensure that the project can be carried out successfully.
- Information on nomination forms and supporting documents collected by HKADC is solely for processing award nominations and arranging assessment. Failure to provide the required information may affect a nominee's assessment for an award.
- Nominees shall not make use of phrases such as "(Name of individual / artist collective / school / group / organisation) was nominated for The XX (no. of edition) Hong Kong Arts Development Awards" for publicity or promotional purposes.
- HKADC reserves the right to disqualify Nominees from being eligible for nomination on the following grounds: The Nominees (or any personnel or partner associated with or involved in the nominated project) has engaged or is engaging in (or HKADC has reason to believe that any such person has engaged or is engaging in) any act or activity that is likely to constitute or cause the occurrence of any offence endangering national security or which would otherwise be contrary to the interest of national security; or such disqualification is in HKADC's opinion necessary for safeguarding national security, or protecting public interest, public morals, public order or public safety. HKADC may disregard or reject all related nomination of the Nominees who have been so disqualified by HKADC in accordance with this paragraph.
- Awardees shall participate in promotional activities in accordance with the HKADC's guidelines.
- All Awardees (and its members, officers, partners, employees, agents, contractors, sub-contractors, freelance artists (as applicable)) must conform with all legislation, rules, regulations and statutory requirements existing in Hong Kong at any time, and must not engage in any act or activity that is likely to constitute or cause the occurrence of any offence endangering national security or which would otherwise be contrary to the interest of national security.

個人資料處理

- 根據個人資料私隱專員發出身分證號碼及其他個人身分代號實務守則（下稱「守則」）第2.3.3條，藝發局有可能收集候選人的身分證號碼或副本，以正確識辨其身分。
- 當提交提名表格，所有提名人 / 機構及候選單位將被視作同意藝發局使用於表格上填報的個人資料。如提名人 / 機構或候選單位不希望收取任何藝發局或有關團體的宣傳資料，請以書面方式致函藝發局。

ARTIST OF THE YEAR

OBJECTIVE

To recognise arts practitioners^{Note 5} who have achieved artistic excellence in their respective art forms.

THE AWARD

- It is organised into a number of categories covering various art forms, including arts criticism, dance^{Note 6}, drama, film^{Note 7}, literary arts, media arts^{Note 8}, music, visual arts and *xiqu*. One award will be presented in each art form.
- Apart from a trophy, each awardee will receive a cash award of HK\$50,000 for supporting his / her / the artist collective's creative work, arts projects or further studies. He / she / the artist collective will be required to submit a brief report to HKADC concerning the use of the cash award within one year.

ELIGIBILITY

- Nominees should be a holder of Hong Kong Identity Card and should be nominated in his / her personal capacity, or as an artist collective^{Note 9};
- Nominations should be made by at least one nominator (in his / her personal capacity or on behalf of an organisation);
- Nominees must possess considerable experience in the relevant art form;
- Records of the nominees' artistic achievements, performances and professional works for 2022 / 23^{Note 10,11}, together with a full resume of their work experiences in the arts sector should be submitted^{Note 12};
- Nominees should have conducted artistic work or activities in Hong Kong or overseas during 2022 / 23. For the literary arts category, publications / works submitted should be first published during 2022 / 23;
- Nominees cannot be nominated in his / her personal capacity and as an artist collective at the same time;
- Nominees cannot be nominated for more than one art form;
- Nominees cannot be nominated for the "Award for Young Artist" concurrently; and
- Recipients of the HKADC's "Artist of the Year" or "Award for Best Artist" cannot compete in his / her personal capacity or as an artist collective in the same art form of "Artist of the Year" again within five years, but they may be nominated in a different category. In other words, recipients of the abovementioned Awards (i.e. The 13th-17th edition / 2018-2022) cannot be nominated for this year's "Artist of the Year" in the same art form in his / her personal capacity or as an artist collective.

ASSESSMENT CRITERIA

- Nominees' artistic achievements, overall performance and professional work records in 2022 / 23 should form the assessment basis. Their artistic achievements over the years will also be taken into consideration;
- Nominees should demonstrate active dedication to the arts, with outstanding contributions and recognised achievements in their respective art forms; and
- Innovation and creativity that demonstrates a unique style.

Note 5 The nominee may be scriptwriter, choreographer, director, composer, performer, creative artist, stage designer / technician, film creative crew member / technician, curator, arts researcher or critic, etc.

Presentation formats include CD-ROMs, websites, DVDs / VCDs, or other creative forms of presentation that use technologies such as computer games, video / sound installations, virtual galleries / performances, etc.

- Apart from a trophy, each awardee will receive a cash award of HK\$25,000 for supporting his / her / the artist collective's creative work, arts projects or further studies. He / she / the artist collective will be required to submit a brief report to HKADC concerning the use of the cash award within one year.

ELIGIBILITY

- Nominees should be a holder of Hong Kong Identity Card and should be nominated in their personal capacity, or as an artist collective^{Note 17}. They should be 40 years of age or below on the date nomination closes;
- Nominations should be made by at least one nominator (in his / her personal capacity or on behalf of an organisation);
- Nominees must possess at least three years of relevant working experience;
- Records of the nominees' relevant work achievements, performances and professional works for 2022 / 23^{Note 18, 19}, together with a full resume of their work experiences in the arts sector should be submitted^{Note 20};
- Nominees should have conducted artistic work or activities in Hong Kong or overseas during 2022 / 23. For the literary arts category, publications / works submitted should be first published during 2022 / 23;
- Nominees cannot be nominated for more than one art form;
- Nominees cannot be nominated for "Artist of the Year" concurrently; and
- Recipients of the HKADC's "Rising Artist Award", "Award for Outstanding Young Artist" and "Award for Young Artist" cannot compete in the same art form of "Award for Young Artist" in his / her personal capacity or as an artist collective for which they previously received an award, but they may be nominated in a different category.

ASSESSMENT CRITERIA

- Nominees' artistic achievements, overall performance and professional work records in 2022 / 23;
- Nominees should demonstrate innovation and creativity in their artistic works; and
- Active dedication to the arts, and exemplify potential to be a new force in the arts sector.

- A project report on an arts education project implemented and completed by the nominee during the academic year 2022 / 23^{Note 21} should be submitted^{Note 22} (The project may consist of a single programme or a series of programmes implemented in phases), assessment shall be based on the achievements of the project;
- Each nominee should submit only one project for this award; and
- Previous award recipients may be nominated for this award again.

ASSESSMENT CRITERIA

- The project's objective, including educational value, creativity and uniqueness;
- The project's planning and implementation, such as the quality of art, resource management, participation and support of the school and teachers;
- The project's effectiveness in promotion, such as the number of student participants, the performance in cultivating students' interest in arts, stimulating creativity, enhancing students' cognition and appreciation of arts; and
- The project's sustainability, such as the continuity of teaching materials, the extension of activities.

- The attractiveness of the project, such as arousing public's interest, deepening understanding and facilitating participation and discussion in arts;

- The overall promotional and educational plan, such as promotional methods, publicity channels and strategies, the breadth of audience base and the number of participants, developing new audienceship and enhancing public's understanding in arts.

- Only sponsorships towards Hong Kong-based arts organisations / practitioners and local productions that mainly involved local arts practitioners are eligible for nomination; sponsored activities should have taken place during 2022 / 23; and
- Previous award recipients may be nominated for this award again.

ASSESSMENT CRITERIA

- The overall impact of the sponsorship programme(s);
- The programme(s) may include cash donations, in-kind sponsorship and / or other resources (e.g. venues, manpower, publicity channels, etc.).
